Chapter Meeting Reports

Copyright Basics

Using content without permission violates Principle 1 of the AMWA Code of Ethics: "Medical Communicators should recognize and observe statutes and regulations pertaining to the materials they write, edit, or otherwise develop." To help us to stay on the right side of this issue, our AMWA colleague Jill Shuman, MS, ELS—science writer, library director, and certified copyright specialist—provided advice in a webinar hosted by the New England Chapter in September: "Copyright 101: A Practical Guide to Properly Reusing and Sharing Information".

Copyright restrictions apply to journal articles (including those that are open access), posters, internet content, music, and questionnaires and scales. Medical writers inadvertently violate copyright when they use an image in a patient education piece, include a paper in a regulatory submission, or use academic library privileges for commercial purposes.

If you purchase a journal article online, you have the right to view, download, and print the article for your own use. However, to share the content with others, post it on social media, or save it on a CD-ROM or memory stick, you may need to obtain additional permissions from the copyright holder. In most cases the copyright holder is a publisher or company rather than the author.

Jill had a number of practical tips to help us to respect copyright laws:

- Think before you include, share, or post!
- Obtain permission from the copyright holder before you use content in a way other than personal use.
- When possible, share a link to content rather than the content itself. If the content is available for free on the internet, then you do not need permission to share a link to the content.
- Avoid ResearchGate and Sci-Hub; they routinely violate copyright law.
- PubMed provides information on permissions granted for each article and how to purchase additional permissions.
- Use Google to search for copyright-free images.
- Familiarize yourself with your organization's standard operating procedures related to intellectual property.
- If your organization has a librarian, make friends with them! They can be great resource in helping you navigate copyright restrictions.

Jill's engaging presentation included a number of polls that challenged participants to decide whether a specific scenario is a copyright violation or not.

Storytelling in Medicine

Storytelling is how we communicate information, build relationships, and foster empathy. The case report, which is at the heart of medicine, is itself a form of storytelling. There are examples of case reports written as learning tools for physicians as early as the Edwin Smith Papyrus, circa 1600 BCE.

At the chapter's virtual event in December—a presentation on "Narrative and Storytelling in Medicine"—Suzanne Koven, MD, MFA, a primary care physician and Massachusetts General Hospital Writer in Residence, shared the story of her career as a writer and how it has complemented her career as a physician. According to Koven, practicing medicine requires both left brain functions (logic, facts, and analysis) and right brain functions (empathy, holistic thinking, and intuition). "What I learned reading novels in college," she said, "was much more useful to me in the practice of medicine than organic chemistry."

When patients speak with their physician, they don't just convey individual data points about their health; they tell a story. Where patients begin the story and how they tell it are crucial for diagnosis and treatment. Stories have the power to heal trauma, relieve stress, and amplify voices less often heard. Dr. Koven spoke about the barriers to writing encountered by physicians and how what they think they want to write about is sometimes different than what they need to write about. Dr. Koven's work has appeared in the *Boston Globe*, the *New England Journal of Medicine*, *The Lancet*, newyorker.com, and STAT. You can find links to many of her articles on her website, http://suzannekoven.com/. An essay collection, *Letter to a Young Female Physician*, will be released this spring.
