Patient Safety: Turning the Tide on Medical Error

Preventable errors in patient care occur not only in hospitals, but also in nursing homes, pharmacies, physicians' and dentists' offices, and other sites where patients receive care. A recent report estimated that nearly 62,000 medical errors occurred in one year in Massachusetts alone, saddling many patients with lasting physical, emotional, and financial harm. Reducing such errors and ensuring patient safety are challenges that require coordination and vigilance among many stakeholders in our complex healthcare system.

Please join us via Zoom on **Tuesday, June 1, from 7:00 to 8:00 p.m.,** for a presentation on reducing the incidence of medical errors. Barbara Fain, JD, MPP, executive director of the Boston-based Betsy Lehman Center for Patient Safety, will present "Speaking of Patient Safety: Turning the Tide on Medical Error." The Q&A will be moderated by our chapter colleague Victoria Wilcox, PhD.

Ms. Fain has taught public health law at the Tufts University School of Medicine and has provided consulting services in the areas of health policy development, public engagement, and strategic planning to government agencies, academic and research institutions, and health care organizations. She also served in the Massachusetts Attorney General's Office where she oversaw the state's hospital Community Benefit Guidelines and has led many other major health policy initiatives.

The Betsy Lehman Center is a Massachusetts state agency that coordinates a statewide program of research, communications, and collaboration to lessen medical harm. Ms. Fain has served as its executive director since 2013. The Center is named for a *Boston Globe* health reporter who died in 1994 after a preventable and substantial overdose of chemotherapy during breast cancer treatment.

Updating Chapter Bylaws During Pandemic: A Team Effort!

Thinking back to this time last year, you might remember a flurry of emails asking (begging) for your vote at a Special Meeting, either in person or by proxy, to approve the revised chapter bylaws. Some of you might remember receiving a phone call from a chapter volunteer who explained why your vote mattered so much. On the anniversary of the Special Meeting, I want to take a moment to update the chapter membership on the status of our Bylaws and Articles of Organization.

In February 2017, the New England Chapter of the American Medical Writers Association filed "Articles of Organization" and officially became a 501(c)3 nonprofit corporation in the Commonwealth of Massachusetts. Although the chapter already had approved bylaws that

Chapter Officers for 2021-22 Year

outlined how the chapter was to be governed, changes to the legal relationship between individual chapters and AMWA National required the bylaws to be updated. AMWA National had anticipated this requirement and provided draft chapter bylaws in 2018. The chapter formed a Bylaws & Governance Committee and began working with a nonprofit lawyer to ensure the chapter's bylaws would be in compliance with Massachusetts nonprofit law. Together, we revised the chapter bylaws and submitted them to the AMWA Board of Directors for approval in 2019.

In many states, the process would have been complete after this step. In Massachusetts, however, unless the chapter's directors are authorized by the Articles of Organization to amend the bylaws, the power to do so resides with the nonprofit's membership. Since the chapter's original Articles of Organization did not authorize the directors to amend the bylaws, Massachusetts law required two-thirds of the chapter's membership to vote at a Special Meeting to approve changes to both the Articles of Organization and the Chapter Bylaws. With over 300 members in six states, this was not an easy feat!

We had originally planned to hold the Special Meeting in conjunction with the annual roundtable brunch on March 22, 2020, hoping for a great turnout and relying on electronic voting for those members that could not attend. On March 18, we had received just over half the number of votes we needed and were faced with cancelling the roundtable brunch due to the COVID-19 pandemic. At that point, we were convinced we would have to start over. Fortunately, we learned that we could keep the proxy votes we had already collected for 6 months, which gave us enough time to reschedule the Special Meeting to coincide with our annual membership meeting that is typically held in June. This was when the flurry of emails really intensified (apologies to your inboxes). As the meeting date approached, we inched closer and closer to our goal. Finally, on June 29, 2020 we had collected a total of 221 votes, surpassing the two-thirds threshold that was required. The revised Articles of Organization and Chapter Bylaws were submitted to the Commonwealth of Massachusetts and to AMWA National in August 2020.

This was truly a team effort. I thank the chapter membership for responding to this important request. We could not have done this without your participation. I also thank the members of the Bylaws & Governance Committee, Theresa Singleton and Dara Chadwick, for their countless hours reviewing and revising the language in the bylaws. Special thanks also to Ellie Lin, chapter secretary, for validating and tallying the votes and for filing the documents. Finally, I thank the rest of the New England

Chapter officers and volunteers—in particular, Brian Head, Haifa Kassis, Ana Bozas, and Margaret Burke—for taking the time to make phone calls to chapter members in the last days before the vote.
